Denise – we are nearly in position to sign the Contract. Upon final review and internal discussion, we have some final changes and note that there are conflicting sections with respect to our Capped Fee.

In light of our current time expended, which exceeds \$37,000, and the scope of the work we have been handling, we request amending Item 2 to indicate a \$50,000 Cap, which is consistent with that noted in Item 10. Did we previously agree to have that Cap lowered, perhaps for a lesser scope?

We understood that Cap was to take us through December 31, 2017, the end of the calendar year, not the term year. Can you clarify that and incorporate into Item 10 as well.

Once these items have been clarified, I can have Jim sign the required copies and overnight them to you. Trying to get this finalized.
