ITEMIZED STATEMENT IN SUPPORT OF BILL OF COSTS ON BEHALF OF PLAINTIFFS-APPELLANTS CHAIM BOOK, YOSIFA BOOK AND STEPHEN BRENNER

On October 24, 2002, the panel of the United States Court of Appeals for the Third Circuit issued a decision in favor of Plaintiffs-Appellants. Pursuant to this decision, Plaintiffs-Appellants Chaim Book, Yosifa Book and Stephen Brenner ("Plaintiffs-Appellants") submit this itemized statement in support of their Bill of Costs.

The primary brief filed on behalf of Plaintiffs-Appellants contained 77 pages (including appendices) and was bound. Pursuant to the Third Circuit's Local Rule of Appellate Procedure 39.3(c)(2), photocopying costs are assessed at \$0.10 per page in addition to \$4.00 for binding per copy. In addition, the Local Rule also allows for a charge of \$40.00 for covers when dealing with 20 copies or less. Local Rule 39.3(a) states that costs will be allowed for the ten copies of

the brief filed with the Court in addition to the two copies of the brief filed with "each party separately represented." Plaintiffs-Appellants assert that, pursuant to this Rule, they are entitled to assess costs for the reproduction of 14 copies of the brief – ten copies to the Court, two copies to counsel for Defendants-Appellees and two copies for Plaintiffs-Appellants Tenafly Eruv

Association, et al.

Therefore, copies of the primary brief filed by Plaintiffs-Appellants should be taxed at \$203.80. Each copy of the brief incurred an expense of \$11.70, and a single fee for covers of \$40.00 is to be assessed. This amounts to \$203.80.

The reply brief filed on behalf of Plaintiffs-Appellants contained 19 pages and was bound. Pursuant to the Local Rules in addition to the number of briefs set forth above, copies of the reply brief filed by Plaintiffs-Appellants should be taxed at \$112.60. Each copy of the brief incurred an expense of \$5.90, and a single fee for covers of \$40.00 is to be assessed. This amounts to \$112.60.

Finally, the Docketing Fee for Case Number 01-3301 was incurred by Plaintiffs-Appellants. The Docketing Fee was \$100.00.

Therefore, the total costs due to Plaintiffs-Appellants constitutes \$416.40.
