Re: Objection to Petition to Recall Mahwah Mayor William Laforet

Dear Ms. Coviello:

We represent the Honorable William Laforet, Mayor of the Township of Mahwah ("Mayor" or "Mayor Laforet"), with respect to the petition to recall Laforet (the "Recall Petition(s)") submitted by the "Committee to Recall Mayor William Laforet" (the "Recall Committee").

This letter shall serve as Mayor Laforet's objection to your incorrect July 11, 2018 determination that the Recall Petition satisfied statutory requirements and contained sufficient valid signatures to proceed under N.J.S.A. 19:27A-12. As set forth below, your initial determination, in your role as the statutory Recall Election Official ("REO") is incorrect because of the Recall Committee's failure to sign petitions they circulated, violations of statutory procedures to obtain signatures, failure to obtain enough signatures, violations of the duties and obligations as the REO, and other irregularities and/or violations of applicable law. For each of these independent reasons, the Recall Petition is void and must be rejected.

STATEMENT OF FACTS

On November 8, 2016, Mayor Laforet was re-elected to a second four-year term to serve as the Mayor of the Township of Mahwah. On January 6, 2017, Mayor Laforet was sworn-in to a four-year term as Mayor of the Township of Mahwah through December 31, 2020.

On or before January 8, 2018, it appears that a recall committee was formed consisting of Melanie Sue, Vincent Maiello, Darlene Mikolajczk, and Brian Riback (the "Recall Committee"). On January 8, 2018, the Recall Committee filed a Notice of Intention to Circulate Petitions with the REO. On January 9, 2018, the REO certified the Notice of Intention to Circulate Petitions.

Upon information and belief, in mid-January 2018, the REO approved the format of the Recall Petition without a statement of reasons for the recall, or a response from the elected official subject to the recall as permitted by N.J.S.A. 19:27A-8(c). On the very same day, the Recall Committee began circulating the Recall Petition with a color cover sheet on a flyer that contained the following statement of reasons for the recall on behalf of the Recall Committee:

The Township of Mahwah is currently embroiled in several lawsuits and facing a tremendous amount of negative press. At the center of it all are the actions of Mayor William Laforet. Laforet is guilty of:

- INCOMPOTENT MANAGEMENT, POOR JUDGMENT, AND ABUSE OF POWER resulting in multiple lawsuits which could easily cost taxpayers in excess of \$60,000,000.
- BLATANT LYING to the public about his knowledge of planned expansion of non-resident partisan political groups into Mahwah.
- BREACHING HIS ETHICAL AND FIDUCIARY RESPONSIBILITIES
 by ignoring the town's attorneys and making statements to the media
 designed to undermine the town's legal positions and defame its
 reputation.
- ENCOURAGING DIVISIVENESS within Mahwah by endorsing lies and hate-mongering perpetuated by non-residents.
- Laforet has completely failed as a leader in bringing our community together. It is time for Mahwah and its residents to stop paying for the mistakes of its incompetent, untrustworthy, unethical, and selfish mayor. William Laforet must be removed from office now.

On the reverse side of the leaflet was the following language:

STOP THE CORRUPTION END THE LIES PRESERVE MAHWAH RECALL LAFORET

SIGN THE PETITION Call 201-252-2515 and we'll come to you!

(A copy of the handout statement is attached hereto as Exhibit A).

No similar handout in response stating Mayor Laforet's response was distributed or requested by the Recall Committee in violation of N.J.S.A. 19:27A-8(c).

On June 27, 2018, the Recall Petitions were filed with the REO. On June 28, 2018, the REO allowed the Recall Committee to modify or alter their filing, although it is unclear what process was followed or what exactly was done.

On July 11, 2018, the REO notified the Recall Committee and the Mayor that verification of the Recall Petition was complete and there were sufficient valid signatures to proceed to the next step in the process.

On July 25, 2018, Mayor Laforet submitted the within objection to the REO, pursuant to N.J.S.A. 19:27A-12.

ARGUMENT

I. The Recall Petitions are Void Because They are Not Signed by Each Member of the Recall Committee

It is indisputable that a recall petition must be deemed void when members of the recall committee fail to sign recall petitions that they circulated. As you are no doubt aware, the "Uniform Recall Election Law" (hereinafter the "UREL") establishes the rules and regulations associated with a recall election. The statutory requirements guide the recall process and must be strictly adhered to. Indeed, the UREL must be interpreted with equity and fairness to both those seeking the recall and the individual whose recall is sought. See Dvorkin v. Dover Township, 29 N.J. 303 (1959). See also Comm. to Recall Theresa Casagrande from Office of Spring Lake Heights Sch. Bd. Member v. Casagrande, 304 N.J. Super. 496, 508 (Law. Div.), aff'd, 304 N.J. Super. 421 (App. Div. 1997). The REO must enforce the UREL, including the clear directive that a petition be rejected when it "fails to comply with the provisions of [the UREL]." N.J.S.A. 19:27A-11. Notably, section 8(h) of the UREL mandates that "[e]very member of a recall committee circulating a recall petition shall be deemed void."

N.J.S.A. 19:27A-8(h)(emphases added). Here, this simple requirement has not been satisfied, and as a result, the Recall Petition must – as a matter of law – be deemed void.

It is not disputed that each of the four members of the Recall Committee – Melanie Sue, Vincent Maiello, Darlene Mikolajczyk and Brian Riback – circulated Recall Petitions. As such, pursuant to N.J.S.A. 19:27A-8(h), each of them was required to sign the Recall Petition they circulated. None did, nor does it appear that any members of the Recall Committee (other than one) signed any of the Recall Petitions irrespective of who circulated them. For this reason alone, the Recall Petitions must, pursuant to the clear and unequivocal language of the statute, be deemed void as a matter of law and must be rejected.

II. The Recall Petitions are Void Because the Recall Committee Violated N.J.S.A. 19:27A-8(c)

The Recall Petition must also be rejected because the Recall Committee violated the express requirements of the UREL by circulating an unauthorized statement in support of their Recall Petition, without getting approval of the REO and without providing Mayor Laforet with his statutorily permitted right to respond.

The UREL allows a recall committee to set forth a statement in the petition that explains reasons for the recall. N.J.S.A. 19:27A-8(c). When it does so, the official subject to the recall may provide a response that must also be included in the petition. Ibid. The petition need not contain a statement of reasons and when it does not, a response by the official subject to the recall cannot be included. Ibid. However, notwithstanding the statutory requirements, the Recall Committee's circulators here utilized a cover page flyer (the "Cover Page") that contained statements not properly affixed to the approved form of the Recall Petition as certified by the REO, and not provided to Mayor Laforet so a response could be provided. A true and correct copy of the cover sheet is attached hereto at Exhibit A.

The Cover Page contained statements disseminated by the circulators purportedly containing the Recall Committee's reasons for the recall. Use of the Cover Page violates the clear and unambiguous language of the UREL, and deprived the Mayor of his right to provide a response pursuant to N.J.S.A. 19:27A-8(c).

By handing out a statement to voters without affording the Mayor the opportunity to provide his responsive statement, the Recall Committee and each circulator violated N.J.S.A. 19:27A-9(b)(3), which requires that a circulator must circulate the petition "in absolute good faith for the purpose of causing the recall of the elected official named in the petition." The use of a separate statement of reasons supporting the recall in the Cover Page, while failing to distribute a statement from the Mayor, cannot be justified as anything other than the means of denying the Mayor his statutory opportunity to include his response in the Recall Petition given to individuals approached to indorse the recall petition. This violation infects the sanctity of the recall process set forth by the Legislature and calls into question whether those who indorsed the Recall Petition knew all sides regarding what they were signing. Indeed, use of the Cover Page demonstrates a lack of good faith by the circulators in circulating the Recall Petition, contrary to the law and requires rejection of the Recall Petition in its entirety.

III. The Recall Petitions Do Not Contain Adequate Signatures

According to news reports, it appears that the Recall Election Official and Township Attorney advised publicly on or about June 28, 2018 that only 4,170 valid signatures are required for the Recall Petition to proceed. Indeed, this incorrect claim appears to have been repeated on other occasions by the REO and/or Recall Committee and published in a number of news reports. However, the Recall Election Official's calculation is simply wrong.

It is clear that the UREL mandates that a recall petition be "signed by a number of registered voters of the jurisdiction of the official sought to be recalled equal to 25% of the

persons registered to vote in that jurisdiction on the date of the general election preceding" the notice of intent. N.J.S.A. 19:27A-5.

Thus, based on the REO and Township Attorney's purported calculation of 4,170, there would have been only 16,679 registered voters in Mahwah on November 7, 2017. But, there were more than 17,000 voters registered on this date. In fact, there were 17,364 voters registered in Mahwah as of November 1, 2016 – one year before the calculation date at issue here. Based on the proper 2017 general election registration figure of 17,595, the Recall Committee was obligated to provide at least 4,399 valid signatures of voters. Because they did not, the Recall Petition must be rejected.

Indeed, while the Recall Committee purports to have 5,000 signatures submitted, they do not. The Recall Petition contains substantially less than 5,000 signatures, and in reviewing the Recall Election Officials own notes, as well as the elimination of duplicate signatures, unregistered individuals, those who are otherwise unqualified, false indorsements where someone appears to have signed on behalf of a purported voter, and those not registered to vote as of the date of their indorsement, the number of qualified signatures drops below the aforementioned threshold. This is a fatal defect that requires rejection of the Recall Petitions as a matter of law by the REO.

IV. Government Officials Failure to Turn "Square Corners" During this Tainted Recall Process

Based on the evidence we have received to date, it appears that the REO violated the "Square Corners Doctrine" in its handling of the Recall Petition and in its response to requests for government records relating to the Recall Petition. That doctrine mandates that government officials must "turn square corners" in dealing with the public. The Square Corners Doctrine applies to both the REO and Township Clerk, and the oath to be neutral has been violated by failing to provide complete responses to our OPRA requests, failure to maintain copies of government records, and in allowing the Recall Committee to modify the Recall Petition following its filing.

A. OPRA Requests

On behalf of Mayor Laforet, we filed various requests for documents, pursuant to New Jersey's Open Public Records Act (N.J.S.A. 47:1A-1 et seq.), ("OPRA,"), in an attempt to identify any changes to copies of the filed June 27, 2018 Recall Petitions. A true and exact copy of the June 28, 2018 request is attached hereto as Exhibit B; the June 29, 2018 request is attached hereto as Exhibit D.

On July 18, 2018, our office received documents from the Municipal Clerk forwarded by two emails in response to our July 9, 2018 request for communications between the REO/Township Clerk and the Recall Committee, and the REO/Township Clerk and the Township Council. A true and correct copy of the two emails with attachments from the REO/Township Clerk dated July 18, 2018 is attached hereto as Exhibit E.

Notably, the documents memorialize the following questionable activities:

- An email from REO/Township Clerk Kathy Coviello to Mahwah Township Attorney Brian Chewcaskie, Esq. sent on June 28, 2018 at 10:31 a.m.: "Mrs. Sue has been contacted and will be coming to include the first page of the Petition to the pages which you reviewed in my office this morning. As I requested, I need to have in writing what it is that is invalid in the Petition and where in the statute same is. My question is, Are there any other items which need to be done to the Petition?" (A true and correct copy of the email from REO/Township Clerk Kathy Coviello dated June 28, 2018 is attached hereto as Exhibit F).
- A letter from Brian Chewcaskie, Esq. dated June 28, 2018 to REO/Township Clerk Kathy Coviello: "I have had the opportunity to cursory review some of the petitions that were submitted, and indicated that there should be a correction in order to conform with N.J.S.A. 19:27A-8. As I advised you when reviewing some of the petitions, the circulator had attached to one of the petitions various signature pages which had numerous dates. As I advised you, if a circulator obtains signatures on different dates, the petitions should be affixed to each signature page corresponding to those dates. Although N.J.S.A. 19:27A-8 indicates that 'a petition may consist of any number of separate sections which shall be identical except with respect to information required to be entered thereon by the signers and circulators...' That section refers to the petition itself and not to the required acknowledgment for the signature pages. I did not want a technical requirement to affect the validity of the documentation submitted. It is my understanding that the Recall Committee is addressing same. Irrespective of the foregoing, the petition is deemed filed as of June 27, 2018." (A true and correct copy of the letter from Township Attorney Brian Chewcaskie, Esq. dated June 28, 2018 is attached hereto as Exhibit G).
- An email from Melanie Sue to REO/Township Clerk Kathy Coviello and Mahwah Council President Robert Hermansen sent on June 26, 2018 at 8:49 a.m.: "Please allow for the campaign to address the mayor and council regarding the end of

the recall campaign during the 6/28 council meeting. Thank you. (A true and correct copy of the email from Melanie Sue dated June 26, 2018 is attached hereto as $\underline{\text{Exhibit}}$ $\underline{\text{H}}$).

- An email from Mahwah Council President Robert Hermansen to Melanie Sue copying REO/Township Clerk Kathy Coviello sent on June 26, 2018 at 9:18 a.m.: "There is always time during the 2nd public session to address the council and mayor. From what I understand the date to submit is coming soon. I will put a place holder on the agenda for legal with Kathy in case something happens between now and Thursday. If nothing does then you can address during the 2 [sic] public portion. Kathy, what day is the final day of the Recall?" (A true and correct copy of the email from Mahwah Council President Robert Hermansen dated June 26, 2018 is attached hereto as Exhibit I).
- An email from a Petition signatory to REO/Township Clerk Kathy Coviello sent on July 6, 2018 at 9:38 a.m.: "Please remove my name from the petition that was circulated regarding the removal of Laforet as township mayor. The information provided by the solicitor was false; I would not have signed if I had known then what I know now." (A true and correct copy of the email dated July 6, 2018 is attached hereto as Exhibit J).

The Township Clerk and REO are bound to perform their governmental duties as the record retention officer for the municipality. As such, the Township Clerk was required to make and retain copies of the original filed petitions without alterations exactly as they were received on June 27, 2018. Those copies of the original petitions should have been part of the OPRA production in response to our request of June 27, 2018. To date, we have not received copies of the original, unaltered petitions, nor have we been provided access to same.

B. The Recall Committee Failed to Use the Approved Petition Forms in Violation of the UREL

Based upon information from documents obtained from the Township Clerk in response to our OPRA requests, there are improprieties associated with the filed Recall Petition. It is clear that the Recall Committee did not use the REO-approved Recall Petition forms as required by the UREL. Indeed, the form approved by the Secretary of State was not used in violation of N.J.S.A. 19:27A-8. Specifically, it is clear that signature pages of the Recall Petition that were submitted to you as the REO on June 27, 2018 were incomplete, and at a minimum missing the first page of the Petition booklet with clear identifying information in a 10-point font as required by the UREL (the "Petition Booklet Cover").

The Petition Booklet Cover is required to include critical and statutorily required information including the following: the purpose of obtaining the signatures; "Petition For the Recall of William Laforet From the Office of Mayor of the Township of Mahwah"; the names and signatures of the four Recall Committee members; "the recall election shall be held on at the next general election, November 6, 2018. No special election is requested"; the Statement of the Recall Committee (No Statement Provided); and Answer From the Elected Official (No Answer Provided).

The failure of the Recall Committee to file their Recall Petition in the required manner is a violation of the UREL demonstrates that the approved Recall Petition was not circulated in the form or manner required, and calls the authenticity of the entire Recall Petition into question. As such, the Recall Petition must be rejected on this basis alone.

C. Government Officials Worked with the Recall Committee to Fix the Petition in Violation of the UREL and Square Corners Doctrine

It is clear that the office of the REO became the principle resource for resolving issues and modifying defects in filed Recall Petitions in violation of the UREL.

In an attempt to remedy fatal defects in the filed Recall Petitions, the REO was in contact with members of the Recall Committee and the Mahwah Township Attorney Brian Chewcaskie, Esq., on June 28, 2018 with advice to the Recall Committee to alter the filed Recall Petitions (one day after the REO accepted the Recall Petitions for filing). (See Exhibits \underline{F} and \underline{G}). These actions call into question the impartiality of the REO in the dual role as the REO and Township Clerk, as well as the validity of the Recall Petitions themselves.

In his review of the petitions, Township Attorney Brian Chewcaskie, Esq. pointed out that various signature pages "... had numerous dates. As I advised you, if a circulator obtains signatures on different dates, the petitions should be affixed to each signature page corresponding to those dates." The REO then contacted Melanie Sue, who apparently returned to the REO's office at Township Hall on June 28, 2018 to insert the missing Cover Page to include signature pages with different dates. This revelation from documents obtained through OPRA casts doubt on the veracity of the entire petition. Indeed, it is proof that the Township Attorney and REO provided legal advice to the Recall Committee in the midst of this process and without notifying Mayor Laforet. The fact that the circulator added the Cover Pages after the fact with the REO's assistance begs the question as to whether the signatories were given a chance to see the petition Cover Page as required by the UREL. It also indicates that the signatories may have been asked to simply sign, without reviewing the reason for their

signature, the Committee's declaration of "No Statement" and the "No Answer from Elected Official" sections of the Recall Petition, in violation of the UREL.

Mayor Laforet has observed members of the Township Council instructing government officials in Mahwah to not provide the Mayor with information regarding the recall election. Specifically, Mahwah Council President Robert Hermansen interrupted a conversation between Mayor Laforet and Mahwah Township Attorney Brian Chewcaskie, Esq., and instructed the Township Attorney to refrain from discussing the recall matter with the Mayor. While instructing the Township Attorney not to discuss the Recall Petition with the Mayor, the Council President and the Township Attorney held a private meeting in Township Hall to discuss the Recall Petition and correct the faulty Recall Petitions. ¹

While a municipal clerk performs various tasks to assist the public, a REO must follow the statutory requirements of the UREL. It is well settled that where the Legislature has not given directions to municipal clerks or county clerks in statutory enactments relating to elections, either in specific terms or in language from which the legislative intent can be discerned, as to matters pertaining to the conduct thereof, some decisions must rest within the discretion of such clerks.

The facts stated above demonstrate that the REO/Township Clerk violated its obligations under the UREL as well as the "Square Corners Doctrine" by helping the Recall Committee correct their faulty Recall Petitions by allegedly adding and moving pages of the filed Recall Petitions, while at the same time preventing Mayor Laforet from simply obtaining the original and unaltered filed copies of the Recall Petitions or information regarding same pursuant to OPRA as was the duty of the Township Clerk.

These actions violate the UREL, and the Recall Petitions should be declared void at this time.

V. Other Evidence that Supports Voiding the Recall Petition

There are numerous other reasons to declare the Recall Petition void. Based upon information and belief, members of the Mahwah Township Council, as political opponents of Mayor Laforet, are driving the Recall Petition efforts behind the scenes in an attempt to defy the will of the voters of Mahwah who twice elected Mayor Laforet.

¹ The Township Attorney should not be providing legal advice to either side during the recall process, and his conversations with Mahwah Council President Robert Hermansen about the recall efforts, a political opponent of Mayor Laforet and a leader of the recall efforts, call into question the Township Attorney's impartiality, representation, conflicts and directions in this process.

Also, we have received information that circulators of the Recall Petition communicated false information to signatories (see Exhibit J), including the false claim that Mayor Laforet supported the recall efforts, inducing them to sign. There are also allegations of circulators representing to signatories that the petitions were actually a poll, or that their signatures were necessary to get Mayor Laforet's name on the ballot. There are also allegations that people who were not official circulators went out and obtained signatures that were later incorporated into different Recall Petition packets.

In addition, a cursory review of the Recall Petition reveals numerous irregularities. Some pages of the Recall Petition appear to have been filled out by one spouse on behalf of both the married couple (and in a few cases, the entire family). Some of the petitions had the signature of the circulator on a line with the term "circulator" handwritten by the circulator, as opposed to the printed line with the term "circulator" typed on the form approved by the REO. Notably, some of the pages of the Recall Petition where the voters are required to fill out appear to have been partly filled out by the circulator. For example, parts of the voter's address are written in the circulator's handwriting. Other individuals were not registered at the time they signed, or signed the Recall Petition in several places.

As further evidence that the Recall Committee failed to comply with the statutes established for a recall election, the Recall Committee's required filing with the New Jersey Election Law Enforcement Commission ("ELEC") was untimely. The Recall Committee had 10 days (not business days) to file a the RC1 and RC2 forms from "the date the committee is established." Using January 8, 2018 as a starting point, the date the Committee filed the Notice of Intention to Recall, the Committee would have had a January 18, 2018 deadline file these documents. These documents were signed on January 18, 2018, but filed on January 22, 2018. As such, they are not timely.

For all these reasons set forth above, the Recall Petition is void and must be invalidated.

CONCLUSION

Therefore, Mayor Laforet respectfully requests that you as the REO declare the Recall Petition void as non-complaint with the UREL. Mayor Laforet reserves all rights and remedies available to him relating to this matter.



The following is intended to serve to confirm our conversation earlier this date with respect to the recall petition. As you are aware, I have had the opportunity to cursory review some of the petitions that were submitted, and indicated that there should be a correction in order to conform with N.I.S.A. 19:27A-8. As I advised you when reviewing some of the petitions, the circulator had attached to one of the petitions various signature pages which had numerous dates. As I advised you, if a circulator obtains signatures on different dates, the petitions should be affixed to each signature page corresponding to those dates.

Although N.J.S.A. 19:27A-8 indicates that "a petition may consist of any number of separate sections which shall be identical except with respect to information required to be entered thereon by the signers and circulators...". That section refers to the petition itself and not to the required acknowledgment for the signature pages. I did not want a technical requirement to affect the validity of the documentation submitted. It is my understanding that the Recall Committee is addressing same.

Irrespective of the foregoing, the petition is deemed filed as of June 27, 2018. In accordance with N.J.S.A. 19:27A-11 you, as the Recall Election Official, have ten (10) business days to determine the total number of signatures affixed thereto and whether the completed petition complies with all other provisions of the Act. The ten (10) business days will commence as of June 27, 2018 and expire July 12, 2018.

Please undertake the necessary steps to determine the adequacy of the number of signatures and compliance with the provisions of the statute,
